Seven chambers and 10 firms: Lawyers prepare for bumper \$13.8bn Russia dispute

Firms including Herbert Smith Freehills, Seladore Legal and Quinn Emanuel are on call in one of the largest ever claims to be brought in the English High Court outside the collective redress regime.

Valued at \$13.8bn, the lawsuit was filed in July by jailed Russian businessman Ziyavudin Magomedov against 22 defendants, including a number of Russian state companies.

Magomedov became a billionaire during Dmitry Medvedev's four-year term as Russian president, which ended in 2012. In December 2022, Magomedov was sentenced to 19 years in jail for embezzlement alongside his brother, having already spent more than four years in prison in 2018 awaiting trial.

Magomedov claims he was wrongly imprisoned and that his business empire was manoeuvred into Russian state hands. Losses argued include a controlling \$8.8bn stake in Russian transport operator FESCO.

The claim is one of the first clear examples of how the legal landscape looks after a host of law firms distanced themselves from Russia following its invasion of Ukraine in February 2022. Of the 10 firms currently representing in this mammoth dispute, only three are full-service – Herbert Smith Freehills, Fieldfisher and Dentons – indicating a resurgence of litigation boutiques.

The claim itself is brought by Seladore Legal, new to the scene, having set up shop in 2020. Seladore has an impressive set of partners behind it, virtually all ex-HSF lawyers, including Simon Bushell, who founded HSF's Russia and CIS disputes practice before leaving the firm in 2013.

The Lawyer understands that four defendants have sanctions placed upon them in some form, including FESCO and Halimeda International, as well as limited sanctions on pipeline operator Transneft. A number of subsidiaries of state-owned nuclear company Rosatom are sanctioned by the British Government, although the parent company itself is not.

FESCO was, up until recently, defended by CANDEY, however the transport operator is now being represented by Quillon Law partner Mark Hastings, who set up his boutique in 2021 and spent most of his career at Addleshaw Goddard. CANDEY partners Yuri Botiuk and James Collins are still representing Halimeda International.

Rosatom, meanwhile, is represented by PCB Byrne's senior partner, Anthony Riem, while Transneft is defended by Enyo partner Lucinda Orr.

HSF seized the mandate to represent US private equity giant TPG, which commonly uses Cleary Gottlieb Steen & Hamilton. HSF's involvement indicates that large firms with reputations for taking

on complex disputes are still finding their way into mega lawsuits coming out of Russia.

Firms representing other defendants include well-established boutique Cooke Young & Keidan and disputes powerhouse Quinn Emanuel Urquhart & Sullivan.

A few parties remain legally unrepresented in this case, including Leyla Mammad Zada, chairperson of the board of directors at FESCO, as well as Katina Papanikolaou, another individual allegedly involved in the conspiracy.

The Lawyer understands that the 13th defendant, Konstantin Kuzovkov, was represented by Mishcon de Reya partner Kasra Nouroozi but that Kuzovkov is now a litigant in person.

Regarding chambers, One Essex Court is the dominant set in this dispute, with six barristers appearing plus five silks, including Lord David Wolfson KC. Other sets making an appearance include Brick Court, leading for the claimants, as well as 4 Stone Buildings, Twenty Essex, Essex Court, 4 New Square and Fountain Court for the defendants.
